ENTRIES CLOSE: 7:00 p.m. EDT on Tuesday Sept. 29, 2020 at the address of the test secretary, after which WC/WCX entries cannot be accepted, cancelled or substituted. NO EXCEPTIONS. Saturday Fun Day: Pre-entries are required and flyers (extra cost) must be ordered in advance.

SCRATCHES: Refunds will be made for sickness, injury, death or bitches in season. Notice must be given to the event secretary prior to the start of the test and a veterinarian's letter on letterhead must be sent to WRGRC within one week of the test date. **Bitches in season are not allowed on the test grounds.**

Purpose and Certification

The WC and WCX are designed to test the working ability of Golden and Flat-Coated Retrievers and will be conducted in accordance with the AKC Field Trial rules as modified by the GRCA and FCRSA. Golden retrievers will be run under the rules set forth by the GRCA while Flat-Coats will be run under the rules set forth by the FCRSA. All retriever breeds, Irish Water Spaniels and Standard Poodles are welcome to enter. However, only Golden and Flat-Coated Retrievers will qualify for certification under these rules. Golden and Flat-Coated Retrievers meeting the test requirements will automatically have their pass recorded with their respective national organization and will subsequently receive a title certificate from either GRCA or FCRSA.

All dogs entered will receive a duck band. All dogs, regardless of breed, that qualify under the rules will receive a card of congratulations from GRCA. A WRGRC memento will be given to all Golden retrievers and other breeds that qualify and a Rosette will be given to Flat-Coated retrievers.

WC/WCX Test Regulations

Copies of the complete WC/WCX requirements will be at the test headquarters and are also available online for Golden retrievers at: www.grca.org/wcwcx.htm and for Flat-Coats at: www.fcrsa.org Gun handling is not required and white clothing may be worn by the dog handler. Arrive on time in order to hear the judges' instructions to the handlers. Dogs will be run in catalog order, unless otherwise requested by the judges.

Amo Conservation Bird Dog Club, 3802 S County Road 550 West, Coatesville, IN 46121 From I-465: Take Exit 13 on west side of Indianapolis to US 36/Rockville Rd. Drive west on US 36 18.07 miles to County Road 450 W. Turn left (south) and drive 2 miles to County Road 200 S. Turn right (west) and drive 1 mile to County Road 550 W. Turn left (south) and drive 1.8 miles and the club is on the right (west) side of the road.

Fun Day Pre-entries are required and flyers must be ordered in advance.
